 (4 Complimentary EXPO Passes) Companies or individuals in the business of providing independent sales representation for manufacturers of hearth, patio or barbecue related products.
- Service \$200** (3 Complimentary EXPO Passes)
 Chimney sweeps, installers, and companies in the business of providing mechanical services relating to hearth, patio or barbecue related.
- Associate \$880** (6 Complimentary EXPO Passes)
 Companies having a commercial interest in hearth, patio or barbecue related products.
- Non-Profit \$180** (3 Complimentary EXPO Passes)
